Phase 1 (ONE) Requirements and Checklist

- 2 hour treatment sessions daily Monday - Friday Mon. Tues. Wed. Thurs. Fri.
- Thursday Court Sessions [4/5 weeks] 3 hours Community Service
- First 30 Days Monday – Saturday UDS Testing Must acquire sponsor/verification
- After first 30 days, a minimum of 3 UDS's/Anytime color is called – to include Saturdays
- Curfew 6 PM - 5AM [If unemployed or until employment has been verified]
- Curfew 9 PM – 5 AM [If employed (must provide proof of employment)]
- Phase 1 is a 90 days' phase. [You will not be permitted to remain in phase 1 for an extended period of time]
- Must be clean a minimum of 30 days to be considered to phase up.
- Must have paid a minimum of \$275 toward program fees & 20% of restitution if applicable to phase up

If you miss a treatment, you are required to make the session up within a set period of time. If you miss court, a warrant will be signed for your arrest. Curfew is not an idea; it is a requirement that will be strictly enforced.
