

**Teen Tech Week 2007  
Photo/Video Contest Rules  
Columbia County Library**

**General rules:**

- All participants must be 12-18 years old at time of submission.
- Submissions will be accepted in person at the Columbia County Library at the reference desk during library hours from February 1 – March 10, 2007.
- Participants must submit their own entry.
- Participants are limited to one photo and/or one video submission.
- Submissions may be displayed in the library.
- Submissions will not be returned.
- No obscene or sexual content will be permitted.
- Submission must not violate any copyright law and must be original work of participant.
- Submission must not promote the use of alcohol or drugs.
- A signed copy of the artist release form must accompany the submission.
- A signed copy of the subject release form must accompany submission from EVERY person depicted in the photo and/or video.
- Submission must be made by an individual and not by a group.
- Submissions must follow all guidelines.
- Entries that do not comply with these rules will be disqualified.
- Incomplete entries will not be accepted. It is the participant's responsibility to make sure entries are complete.

**Video Submission Rules:**

- Videos will be accepted in DVD or VHS format.
- Videos must not exceed 20 minutes in length.
- Videos should include an introduction and credits.
- Submissions must follow all general rules listed above.

**Photo Submission Rules:**

- Photos must be 4 x 6 inches or larger.
- Submissions must follow all general rules listed above.

**Prizes:**

- There will be first, second, and third place prize awarded each in both video and photo categories.
- Prize distribution is as follows:
  - 1<sup>st</sup> place—one iPod Shuffle
  - 2<sup>nd</sup> place—one \$50 Gift Card to Best Buy
  - 3<sup>rd</sup> place—one \$25 Gift Card to Best Buy
