This permit becomes null and void if work or construction authorized is not commenced within 180 days or if construction or work is suspended or abandoned for a period of 180 days at any time after work is commenced.

Any builder constructing residences or any other type construction in the above stated subdivision will be held accountable and responsible for any damages by reason of said construction to curbs, gutters, man holes, catch basins, water mains, etc.

A fee will be charged for each reinspection. This is due and payable prior to release certificate of occupancy.

Columbia County reserves the right to revoke any permit determined to contain falsified information or issued in error.

I understand that the granting of a permit does not waive the provisions of any federal, state or local law regulating construction or the performance of construction.
