Bid Description: The work to be done consists of furnishing all materials, equipment, and labor for the construction of: **Hereford Farm Road at Blanchard Road Intersection Improvements, Bid # 2020030-BID3313**

Proposals for the complete work in one or more general contracts shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

All proposals shall be accompanied by a Bid Bond drawn in favor of the **COLUMBIA COUNTY, GEORGIA**, in the amount of at least ten percent (10%) of the total bid amount for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for the **COLUMBIA COUNTY, GEORGIA**. Each bond shall be equal to one hundred percent (100%) of the contract amount. The Bid Bond shall be forfeited to the **COLUMBIA COUNTY, GEORGIA** as liquidated damages if the Bidder fails to execute the contract and provide Performance and Payment Bonds within ten (10) days after being notified that he has been awarded the contract. Bid bonds must be submitted electronically using <https://columbiacountyga.bonfirehub.com>. **Letters of credit will not be accepted in lieu of bid bonds.**
